Elopak goes for **harmonization** and **standardization** of processes with single company wide **SAP ERP** system

Objectives

The Main Objective was the international harmonization and standardization of end to end processes to enable efficient growth and furthermore to build a foundation for existing and future digital business opportunities of ELOPAK.

One important element to streamline the administrative processes was to establish the principal toller agent model. The Principal hereby owns the goods and these are sold through a central sales department. This model simplifies the administration of the flow of goods since the owner does not change when the goods are moved to a different production location.

Enablers

Solutions

This SAP ERP implementation consists of a single company-wide business administration system. This set-up ensures that the internal administrative burden is reduced and that support functions can be centralized such as master data maintenance, accounts payable, forecasting and that company-wide activities such as reporting, treasury, HR can work from a single platform.
